At the regular monthly Town Meeting held in said town and county, in the state of Illinois at Kendall Township Hall on Tuesday June 18, 2024. Meeting was called to order at 7:35 PM by Supervisor Steve Gengler. Township officials present were Steve Gengler Supervisor, Doug Westphal Highway Commissioner, Cathy Scalise Assessor for Kendall Township and Trustees: Carolyn Pottinger, Don Hirsch, Zach Turnbow and Doug Thanepohn. Steve Grebner, Kendall Township Clerk was absent.

No guests were present.

Supervisor Gengler lead the board in the Pledge of Allegiance to the Flag.

Section III: Sheriff's Dept Representative was not able to attend this month.

Section IV: Public Comment – No public comment was provided.

Section V: Approve May 2024 Meeting Minutes: Minutes from Regular May 2024 meeting were read. Motion to approve minutes was made by Carolyn Pottinger and seconded by Don Hirsch and motion was approved unanimously.

Section VI: Financial Business: General Funds and Road District bills were reviewed and a motion to approve was made by Doug Thanepohn and seconded by Zachary Turnbow. Motion was approved unanimously.

Reports:

Assessor: Assessor stated the office was busy with the assessment process.

Highway Commissioner: Started paving projects. Minkler & Hilltop culvert collapsed and repair was in progress. Many night calls for road closures due to accidents and downed trees.

Clerk's Report: No new report from the Clerk this month.

Supervisor: Supervisor stated research was still being done regarding Cemetery. No additional business to report.

It was moved by Zach Turnbow to suspend the monthly meeting to allow us to have the Public Hearing for both the Road District and Township budgets and was seconded by Don Hirsch. There was no discussion and motion carried. Meeting was suspended at 8:40 PM.

Budget Hearing for Road District Budget Ordinance #24-02 and Township Budget Ordinance #24-03 was called to order at 8:40 PM; Roll was taken and Township officials present were Steve Gengler Supervisor, Doug Westphal Highway Commissioner, Cathy Scalise Assessor for Kendall Township and Trustees: Carolyn Pottinger, Zach Turnbow, Doug Thanepohn and Don Hirsch. Absent was Steve Grebner, Kendall Township Clerk. Discussion ensued; there were no changes to the Road District or Township budgets from the temporary one approved at last meeting. Having no other questions from the floor a motion was made by Zach Turnbow and seconded by Doug Thanepohn to close the Road District and Township Budget Public Hearing. Voice vote was taken and motion passed unanimously. Public Hearing Closed at 8:45 PM

Motion was made by Don Hirsch and seconded by Doug Thanepohn to resume the Regular Meeting at 8:45 PM. Motion Passed Unanimously.

Motion was made to approve the Road District Budget (Ord 24-02) by Doug Thanepohn and seconded by Carolyn Pottinger. Comments from the floor were none and Roll was taken. Motion Passed Unanimously.

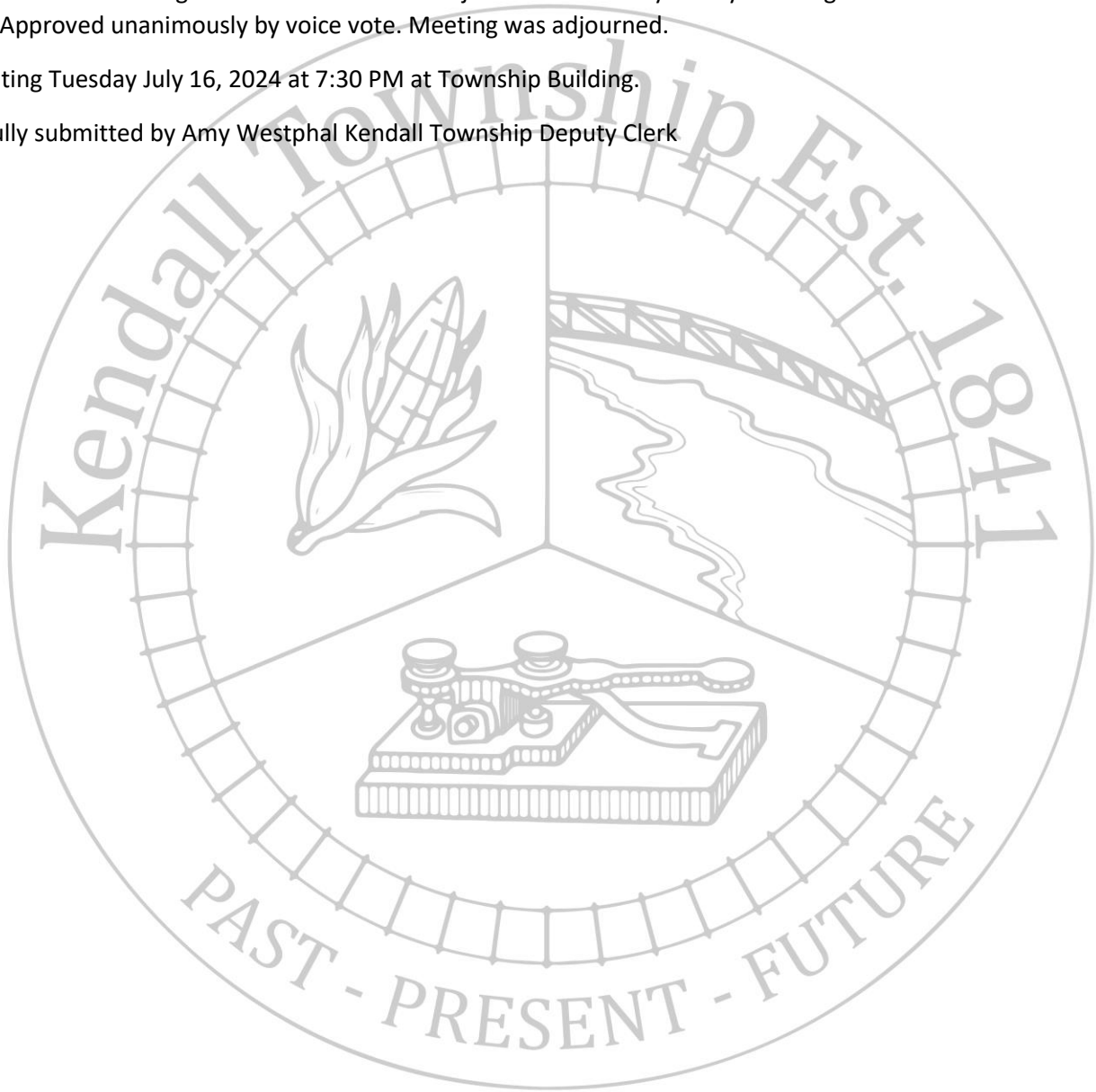

Next meeting Tuesday July 16, 2024 at 7:30 PM at Township Building.

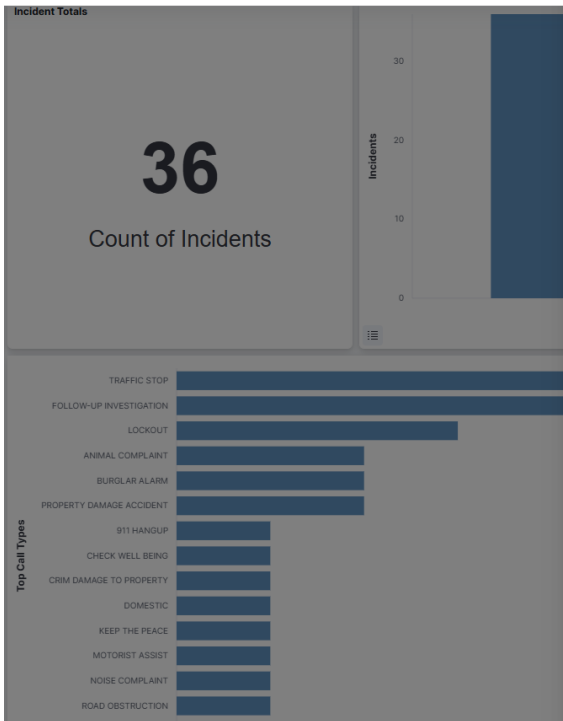

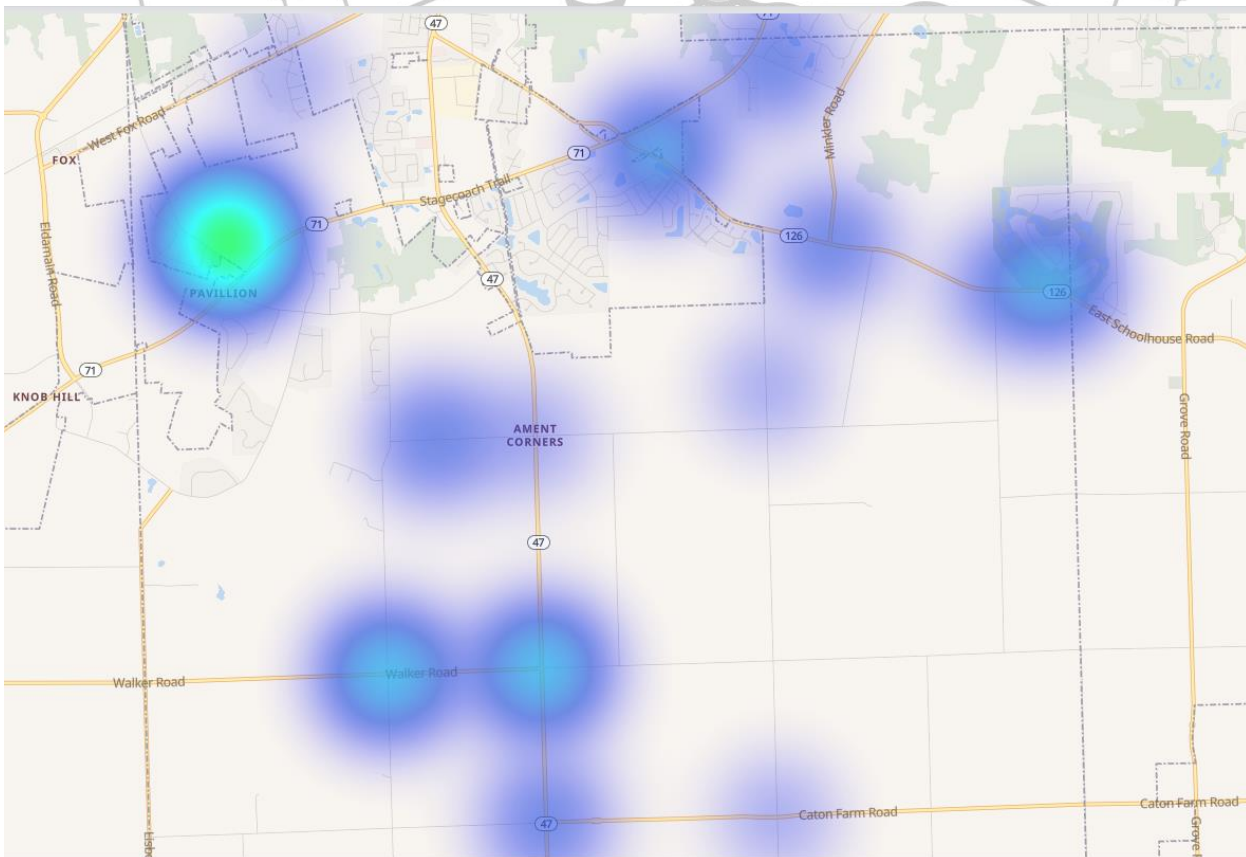

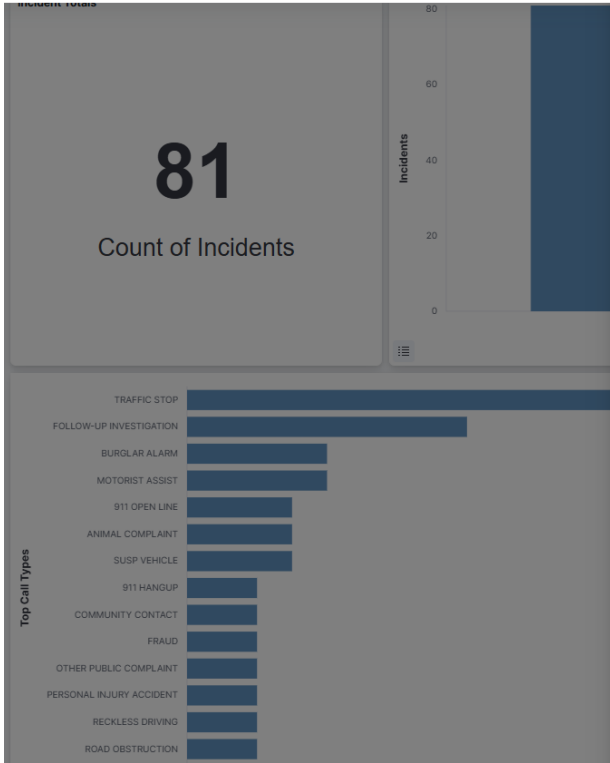
